Playground- Incorporation of BBES Home & School

- This topic had been discussed numerous time and in order to be successful with gov't grants, it was suggested that the H&S become Incorporated. Tammy has been doing research on the process and it is felt that the Committee needs to go ahead and make this official.
- <u>Motion by Tammy and Seconded by Lana. Motion carried unanimously</u> (Angie voted after the meeting) for BBE H&School to become Incorporated.
- Cost would be 57.50 was up front before name search was done.

The remaining fee will be issued after the application is reviewed. The remaining fee of \$112 plus tax will then be paid. As Tammy would have a receipt for name search, I believe we should get her covered for the initial fee and then once remaining fee is paid, funds can issued for 2nd amount. Sheri Motioned and Lana Seconded. All in favour to have funds paid to Tammy as receipts are made available for cost.
