

- Be aware many rooms have 1-way traffic, and occupancy limitations look for signage/arrows.
- Students will sanitize hands with school provided hand sanitizer upon entering the mentoring room.
- There will be hand sanitizer (EZ Pure), 362 cleaner, and paper towel available in the mentoring room.
- and paper towels after every mentoring session Tabletop and shared common materials (including plastic covers of books) to be disinfected by the mentor with provided 362 cleaner
- Prior to leaving at the end of the mentoring session: Games or items that are not easy to disinfect can be put into 72-hour quarantine bin provided in mentoring room.
- Remember to sign-out.
- Wash hands or sanitize on your way out of the building.
