Call to Order / Comments by the Chair:

Kimberley Douglass, Chairperson called the meeting to order at 6:30 p.m. and she welcomed everyone to the public meeting at the Woodstock Education Centre. Kimberley also acknowledged that this meeting was held on unceded Wolastoqiyik territory and that our schools operate on this territory as well.

Consent Items:

Approval of the Agenda - November 16, 2017

The agenda was approved by consensus.

Approval of Minutes from Previous Meeting - October 19, 2017

The minutes were approved by consensus.

Correspondence - Outgoing and Incoming

- An e-mail from an ASD-W School Teacher, Gail Costello was shared with the committee. This letter made the committee aware of a recent loss of a LGBTQ student and for the District Education Council to consider implementing a Mental Health Policy. In addition to this correspondence, a letter was shard from the Leo Hayes High School Parent School Support Committee requesting a Healthy School Policy, Mental Health Policy, and a policy addressing the needs of the LGBTQ community.
- It was noted that the District Education Council address educational issues on a district level with the Superintendent. It is then the responsibility of the Superintendent to monitor and ensure the Council's expectations and goals are being met and reports are provided to the Council from the Superintendent. The District Education Council's policies are governance policies and not operational, as this is the role of the Superintendent through her staff and district policies. It is the belief of the Council, there may be a misunderstanding of who should be developing a Mental Health Policy. Chairperson Kimberley Douglass confirmed that the development of a Mental Health Policy is the role of the District Education Council. The Superintendent's role is to monitor and report back to the Council of how the district is implementing this policy. ACTION: Chairperson Kimberley Douglass shared her intent to respond to the LHHS PSSC Chairperson to make their committee aware that the Council has been looking at the Healthy Living Policy.
- Chairperson Kimberley Douglass shared that an invitation had been given to Eric DeYoung to attend a District Education Council working meeting in January 2018 to present to the Council of why he feels a specific LGBTQ policy should be established in ASD-W.
- The Acting Superintendent shared correspondence that she had received a letter from a parent requesting a LGBTQ policy be implemented in ASD-W. Chairperson Kimberley Douglass responded that this was the role of the Council with the Superintendent monitoring and reporting back to the Council of how this policy was being implemented.

ASD-W District Education Council Page 1 of 4 **Business Arising from the Minutes**

The District Education Council reviewed their 1 and 3 year goals as previously discussed in September 2017.

2017-18 Goals

- 1. To develop a School Health Policy using as a basis the current School Culture and Healthy Living, (including Mental Health, Nutrition and Physical Activity) policies; ASD-W-ER3 and ASD-W-ER5.
- 2. To develop a goal on learning using the Academic Excellence Policy ASD-W-ER2 and align this policy with the 10 Year Education Plan. It was noted that a motion may be passed tonight to remove Quality High School Program Policy ASD-W-ER6 and the Academic Support for Students Involved in the Potato Harvest Program ASD-W-ER7. Therefore, this goal will focus on the Academic Excellence Policy ASD-W-ER2 only.
- 3. Councilor Terry Pond, asked if another goal could be considered to include student representation on the District Education Council so that a student voice can be heard. A discussion was had on how we could accommodate a student to participate in Council meetings in Anglophone West School District. Councilor Terry Pond read why he felt a student voice was needed and he moved the following motion:

 Councilor Mark Noël added that to include a student voice and to act on policies should be included in the motion, but strike the part that allows a student representative to vote on policies as the ability to have one student attend all meetings may need to change.

Be it further resolved that the minister appoint a person to fill the vacant position for the balance of the term in accordance with the Education Act sec 36.7 (9)

This motion was declared to be considered as not being harsh but that we needed to fill this position. A letter will be written to the Minister of Education and Early Childhood Development requesting that the position be declared vacant. Communication will be sent to the First Nation communities of this vacancy and any names should be brought forward

Success stories from schools in ASD-W were shared by the Councilor for that area. Councilors were asked what they would like to see happen to these stories and it was determined that the DEC Portal and the ASD-W website house these stories for everyone to see.

Public Comments

- Hanwell Road representative, Darren MacKenzie, discussed the unfortunate release of Capital Budget with the top two District Education Council requests being ignored. It was discussed as a potential election issue. The council was also disappointed and encouragement was given to the Mayor of Hanwell and Darren MacKenzie for their hard work and efforts.
- Darren MacKenzie and the Council both expressed their sadness when they learned about the recent loss of former students from Oromocto High School.

- There will not be a working meeting in December 2017.
- Councilor Sean Winslow made the council aware of his upcoming absence at the December 2017 Public meeting.
