The following is the School Winter Plan 2022 for Grades 9-12 students and school personnel in New Brunswick public schools. Throughout the winter months, the province may be experiencing high number of COVID-19 cases and an increase in transmission, schools may be directed by Public Health to move in and out of the alert levels.

If students or school personnel have a fever (or signs of fever) or loss of sense of taste or smell, they will not be permitted to attend school until they have a negative COVID-19 test. This test can be either a PCR test or a rapid point-of care-test (POCT). As stand-alone symptoms, elevated body temperature and loss of taste or smell are more specific early indicators for COVID-19, and other highly infectious illnesses.

If students or school personnel have two or more of the following symptoms, they will not be permitted to attend school until they have a negative COVID-19 test a new cough or worsening chronic cough, difficulty breathing, runny nose, sore throat, headache, diarrhea, new onset of fatigue, or purple markings on children's fingers or toes. Having one of these more general symptoms is worth watching; however, having two or more COVID-like symptoms meets the threshold for isolation and testing.

Students are encouraged to bring at least two well-fitted, three-layer masks to school each and ever day as per Public Health guidance.

Isolation	Students and school personnel who test positive and are not vaccinated will be required to isolate for 10 days before returning to school.  Students and school personnel who test positive and are vaccinated will be required to isolate for five (5) days before returning to school.  If a household member of a student or school personnel tests positive, the student or school personnel will not be permitted to attend school for 5-10 days depending on their vaccination status. Handwashing and Sanitizing	Proper handwashing and sanitization is required for all students before and after meals and after using the washroom.  School personnel will monitor students to ensure that they are washing and sanitizing their hands correctly. Concerts and festivals (Christmas concerts, performances, cultural concert, music festivals, etc.)	Concerts and festivals during school hours are permitted. It is highly recommended that these events are organized virtually.  Proof of vaccination will be required for all parents and visitors.  Masks are required for all students, parents and visitors.
