Student Arrival

If students arrive at the school before 8:15am, they must wait in the cafeteria. Students may proceed to their classrooms when the bell rings at 8:15am.

Leaving During the School Day

A student who needs to leave during the instructional day must give his/her homeroom teacher a signed note from their parent and/or guardian. Please note that students will not be dismissed from class to wait in the lobby or outside of the school. Parents/Guardians must come into the school to pick up their child, and the student must sign out in the office before leaving. This policy is in place as a safety precaution, not to cause hardship to you as a parent/guardian. If the student is only leaving for part of the day, he/she will need to sign back in when they return to the school.

Noon Break

Walking students who wish to go home for lunch (within reasonable walking distance) must bring a note from the parent/guardian indicating permission to do so. No other student(s) may leave the school grounds at noon unless accompanied by his/her parent/guardian. The student must sign out at the office before leaving and sign back in when returning. WMS policy states that a parent/guardian will not be able to give written permission for their child to leave the school grounds with another child and/or parent/guardian.

Student Handbook/Student Agenda

At the start of the year, a copy of the Student Handbook went home with all students. It is an insert in your child's agenda book. Please take the time to read through the handbook as it outlines school and district policies and the day-to-day operations of WMS. If you have any questions, please contact the school.

Student Fees

Students are asked to pay a \$30.00 student fee (maximum of \$70.00 for families of 3 or more) which covers the cost of consumables for technology, the student agenda, and a lock for lockers. Some staff and students are <u>scent sensitive</u>; therefore, we are a scent-free school. We ask students and staff not to wear perfumes and strong deodorants. We appreciate your understanding in helping us create a more secure environment for all students.
