1. Welcome

6:34pm Principal McGrath welcomed the group and opened the meeting

2. Introductions/Attendance

6:36pm Everyone introduced themselves and shared their connection to RVMS.

3. Code of Conduct/Purpose of PSSC

6:42pm Principal McGrath reviewed the Code of Conduct.

6:47pm Everyone signed and passed in the Declarations.

4. Selection of 2018/2019 meeting dates

5. Information

a. Sweet Caroline Program

6:52 Principal McGrath outlined the history behind the Sweet Caroline Program. The ASDS Superintendent is on the board for the Program. The Program created a video for middle and high school students to view. They asked that kids be trained in the use of EpiPens. Thirty percent of students in the District have been asked to do a pre-survey and post-survey. RVMS has been selected to do the survey portion in addition to the video itself. The surveys are to assess whether the students are retaining the video information.

The video may be very emotional for some students and, as such, the teachers will do their best to prepare the students for the video. Principal McGrath will be sending the link to the video to PSSC and parents but it is already available on YouTube. RVMS has a kit suitable for both adults and students. The office hosts an extra epipen in the event of an emergency.

The video illustrates how an anaphylactic reaction is not the same for everyone and it may not be the same for the same person. RVMS currently has students with allergies to varying degrees.

b. Cashless Schools

6:59pm Principal McGrath outlined how the cashless school system works. The school got training on how to administer the system. It will be tough to get complete compliance because not every parent has a credit card or wants to use a credit card.

RVMS doesn't fundraise much with a few exceptions (e.g., Quebec trip). As such, RVMS needs parents to pay the student fee. The student fee is voted on by the PSSC each spring for the proceeding fall. The cashless school system costs RVMS 4% per transaction. The Program is implemented throughout the District.

c. School Messenger

7:08pm Messenger reads from the SchoolConnects data sheets and generates Safe Arrivals from that point. It has not worked perfectly but it is improving. Parents can use the School Messenger app to advise the school a child will be home. The default is that the student is present. That said, teachers appreciate receiving an email note that the child will be absent.

The PSSC discussed whether parents should get the principal messages via voice mail and electric mail. Principal McGrath is going to do the last voice mail tomorrow, September 25, 2018 and from that point onward it will be just via email (no more voice mail).

6. Parent Pickup/Drop off

7:18 Dan Pusey asked to revisit the issue of parent pickup/drop issue from last year. Principal McGrath affirmed that cars cannot be in the bus loading/unloading areas while buses are loading/unloading.

- parking lot to east of school
- Rink side of cement barriers

Discussion considered bigger signs for the issue and Principal McGrath will enquire into sign opportunities. As well, she will remind parents in her next weekly message.
