Attendance

Regular attendance at school is very important for a student's education. If a student is absent from school, a <u>written</u> excuse must be presented upon returning to classes. The excuse <u>must</u> state the <u>date</u> the student was absent and the <u>reason</u> for the absence and must be signed by the parent or guardian of the student.

Students are expected to be at school on time. Parents will be contacted if this becomes a persistent problem. This is in accordance with the ASD-S Attendance Policy.

Dress Code

In keeping with Policy 307, The Positive Learning Environment Policy, the following dress code will apply.

- Hats will be removed upon entering the building
- Indoor shoes (for gym and class) must be worn. No outdoor footwear or boots.
- Clothing with inappropriate language, including but not limited to advertising for alcohol or drugs, will not be permitted
- Clothing must cover skin from neck to mid-thigh. Dresses, skirts, or shorts will come to
 at least the mid thigh. Sleeveless shirts are permitted during warm weather or physical
 activity but no spaghetti straps
- Flip-flop shoes, can present a safety hazard and are not permitted at any time. Parents should consider safety and comfort when buying footwear.
- V-Neck or low-cut shirts will be appropriately covered underneath
- School administration will make the final decision on whether or not clothing is appropriate

Students should dress for the weather as all students are expected to be outside during the day.

Supervision

Students are supervised by teachers from bus arrival until the last bus departure. Students who walk, bike, or are driven should <u>not</u> arrive at the school before **7:30am**. Please do <u>not</u> send a note asking for your child to be supervised inside the building unless there is a serious medical problem. If there is a problem of this nature, please contact the principal.

Unexpected Happenings

The school has an Emergency Measures Plan should a serious event occur. This plan includes transportation for the students to a safe location. Depending upon the nature of the event, the safe location would be either Fundy High in St. George, or Barnhill Memorial School in Saint John. This plan would only be put into action when the community was evacuated.

If a student becomes ill or is injured, an attempt will be made to contact the parents/guardians or the emergency contact. In the event of a serious injury the school will also contact 911.

If the school is closed unexpectedly, your child should know where to go if you are not home. Please make sure that he/she does.

Visitors

- All visitors are asked to <u>sign in</u> at the office upon entering the school. Also, we have a buzz-in system. The school asks that you press the button on the lower box to contact the office before trying the school bell.
- Parking must be in the **parking lot**.
- No vehicles except school buses and handicap vehicles are permitted in front of the school during school hours.

School Grounds

The car park area is off limits to students at all times unless accompanied by an adult to or from a vehicle. The following activities are **not** to take place on the school grounds:

- Throwing rocks
- Throwing snowballs
- Fighting
- Rough play
- Inappropriate language
- Gum Chewing

School Equipment

Desks and furniture belong to the Province of New Brunswick, Anglophone South School District, and Fundy Shores School and as such may be searched at any time by school personnel. Any willful damage to school equipment, including walls in the washrooms, will be paid for by the student responsible.

Volunteers

In accordance with the Department of Education Policy 701 any adult including parents and volunteers **must have a current criminal records check**. If you have submitted one in a previous year (to our school) you are not required to submit one again.

Extra-Curricular Activities

We are pleased to offer a variety of extra-curricular activities to our students; however, it is $\underline{\text{the}}$ responsibility of the parent to arrange transportation to and from the event for their own child.

Smoking

In accordance with legislation by the province of New Brunswick smoking is <u>not</u> permitted anywhere on provincial property. This includes schools, school grounds and cars parked on school grounds. "The Act makes provision for fines against persons who smoke where it is prohibited and also those responsible for the management of premises who do not enforce the smoking restrictions within their jurisdiction."

Electronic Devices

Electronic devices such as hand held video games, i-pods, cell phones etc. will not be brought to school. If found such devices will be confiscated by a staff member and returned at a later time.

Storm Days

If school is closed due to inclement weather, the announcement will be made on the radio or you may call the Snow Line at 643-7669. It is also posted on Twitter by @ASD_South. If school is closed for any reason during the day we will be sending an electronic voice message. If your phone indicates that the message was not received we will phone manually.

Derogatory Statements

Inappropriate language of a derogatory nature which includes but is not limited to a sexual connotation will not be tolerated at this school. This will result in disciplinary action which may include but is not limited to immediate out of school suspension. Please support us in this statement as we endeavor to make Fundy Shores School a positive learning environment for all students.

Messages Left for Children

Parents should note that we <u>cannot</u> guarantee that messages left for your child on our phone system will be heard immediately. If we do not call back to confirm we received the message parents should not assume that the message has been received.

School Grounds After School Hours

Children (under 19) are <u>not</u> permitted on school grounds or equipment after school hours unless accompanied by a responsible adult. This is for the safety of the children and the protection of the school property.

Request for Alternate Transportation Service

[ie. pick up in the morning at home stop, delivering after school to day care]

Parents/Guardians may request to have their child/children delivered to an alternate address. Students <u>MAY</u> be permitted to travel to an alternate address providing all of the following conditions are met:

- o a "Request for Alternate Transportation" form, with parent/guardian's signature is submitted to and approved by the school; and
- o the service requested is to be applied <u>everyday to the same location</u> (e.g. every afternoon to a babysitter); and
- o the request can be accommodated by an existing route and stop; and
- the school bus has space for extra passengers.

In other words, we will make every attempt to accommodate such requests as long as there is a consistency to the service provided. We will not approve alternate requests for multiple locations, such as delivery to home stop some days and to a daycare on other days.

Safe Arrival & Attendance

In ASD-S one of our greatest priorities is ensuring that all our students arrive safely at school each and every day.

To enhance our existing absence-checking procedure, we are introducing *a new, more efficient* student absence reporting system called **Safe Arrival**. This new system will reduce the time it takes to verify student attendance, make it easy for you to report your child's absence and easy for staff to respond to unexplained student absences.

With **Safe Arrival**, you are asked to report your child's absence in advance using any of these 3 convenient methods:

- Using your mobile device, download and install the SchoolMessenger app from the Apple App Store or the Google Play Store (or from the links at https://go.schoolmessenger.ca). The first time you use the app, select Sign Up to create your account. Select Attendance then Report an Absence.
- 2. Use the Safe Arrival website, https://go.schoolmessenger.ca. The first time you use the website, select Sign Up to create your account. Select Attendance then Report an Absence.
- 3. Call the toll-free number **1-833-219-9065** to report an absence using the automated phone system.

These options are available 24 hours/day, 7 days a week. Future absences can be reported at any time.

In addition, we will use the **SchoolMessenger Communicate** automated notification system to contact parents whose child is absent when the absence was not reported in advance. The automated notification system will attempt to contact parents at multiple contact points until a reason is submitted for the absence. If our system is unable to reach the designated contacts, office staff will follow up.

If you report your child's absence in advance using the **Safe Arrival** toll-free number, website or mobile app, you will NOT receive these notifications.

Please report absences in advance using **Safe Arrival** instead of sending notes or calling/emailing the school.
